**Ends: November 21, 2021 @ 10:00 PM**

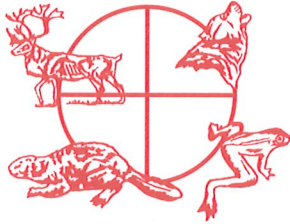

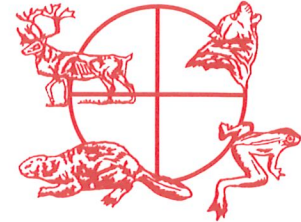

Notice to Tl'azt'enne Band Members

Some concerns from Band Members were raised regarding Councillor Leslie Aslin accepting his Nomination for the Chief's position. I had to seek advice from Charlene Tom, Executive Assistant who contacted the Governance Officer at Indigenous Services Canada. The following attachment explains Iris Michaels comment that "if it's a General Election for all positions, I see no reason why someone should step down from their council seat"

Chief and Council held a duly convened meeting this morning and passed the following motion which I received from Charlene Tom, Executive Assistant.

**It was MOVED (Cllr.Fabian Tom) and SECONDED (Cllr.Allen Robert)**

That the Tl'azt'en Chief and Council based on an opinion of the Governance Office of Indigenous Service Canada agree that a person in a current council seat does not have to resign their current council position to accept their nomination and run for Chief in the current election and if the person gets elected for Chief there will be a bi-election for the vacant council seat.
