

Instructions for Nominees



Dear Nominee:

Congratulations on being nominated as a candidate in the elections to be held on this day of JUNE 25, 2024.

Now that you were nominated, if you would like to be a candidate, you need to complete a few more steps.

You must submit the following by JUNE 28, 2024 (3-day deadline DATE).

1. You must complete the candidate acceptance & declaration form. By doing so, you confirm you are an eligible candidate as per the Tl'azt'en Election Code.
 2. A 1-page candidate profile describing yourself (a template is attached)
 3. A non-refundable \$200 candidate fee for Chief or a \$100 candidate fee for Councillor in the form of cash, money order, certified cheque, or e-transfer payable to the Tl'azt'en Nation.
 4. Criminal record check (dated within the last 6 months prior to the submission deadline)
 5. Current Letter of Financial Standing (received from the Tl'azt'en Nation Finance Office)
- ❖ **If the Electoral Officer does not receive the above items within 3 days of the close of the nomination meeting, you will not be a candidate in this election.**
- **With the Exception being, of a death or natural event that has postponed the election process for the Nation that is directed by Chief and Council.**

All-Candidate Forum

An all-candidate forum shall be held so you may inform the voters about yourself. The forum will be held on JULY 24 at (SEE IN WEBSITE) You are requested to attend and if required, you may attend virtually. The Electoral Officer will provide you the format of the All-Candidate Forum in the coming week.


Scrutineers

You are entitled to have 1 scrutineer at a poll at any one time to observe the conduct of voting, registration at the time of voting and counting of the ballots on behalf of the Candidate but may not otherwise take part in the conduct of the Poll. If you wish to appoint scrutineers, please complete the attached Scrutineer Appointment Form, and have the scrutineers provide the form to the electoral officer when they come to scrutineer.

Withdraw of Candidacy

If, after accepting your nomination, you wish to withdraw, you may do so by providing the Electoral Officer with a completed Withdrawal Form (attached).

CANDIDATE for CHIEF - ACCEPTANCE and DECLARATION FORM



I, _____ of Tl'azt'en Nation, status card # 617 _____
(full legal name)

hereby, accept my nomination as a Candidate for Chief for the election of the Tl'azt'en Nation to be held on this day of AUGUST 7, 2024.

I further solemnly declare that I:

1. Am a member of the Tl'azt'en Nation and have been so for at least 24 months preceding the Election;
2. Am at least 25 years of age;
3. If born after 1965, or have a minimum of a Grade 12 or Equivalent;
4. Have not been convicted of an indictable criminal offence within the 5 years prior to the date of the nomination meeting, unless:
 - a. (i) I have been granted a pardon (including pardons received through a traditional justice process), or
 - b. (ii) the conviction is directly related to a recognized assertion of Aboriginal Rights or Title;
5. Do not have a civil court judgement against me or a criminal conviction in respect of any matter involving theft, fraud or misuse of property within the five (5) years before the date of the nomination meeting;
6. Am in Good Financial Standing, meaning not having arrears or unauthorized debt owing to Tl'azt'en Nation or any entity owned, controlled, or managed by Tl'azt'en Nation, unless:
 - a. (i) I have a debt repayment agreement that is entered into at least six (6) months before election day, and
 - b. (ii) I am in good standing in relation to their debt repayment agreement.
7. Am not an employee of Tl'azt'en Nation and if I am an employee of Tl'azt'en Nation, I, prior to the submission of this candidate acceptance and declaration form, either resigned my position or took a leave of my position during the campaign, with the possibility of applying for paid leave in accordance with policies and procedures of the Nation;
8. Have not been removed from a position on Council within the five (5) years prior the date of the nomination meeting;
9. Have not been on council for the 3 consecutive terms immediately prior to this election.

Along with this form I have submitted:

1. A 1-page candidate profile (in the format provided for by appendix 3M)
2. A criminal record check from within the last 6 months
3. A payment of \$200
4. A current letter of Financial Good Standing from the Tl'azt'en Nation Finance Controller.

If elected, I am committed to take office by physically working in community. This would require me to reside in the vicinity of Tache (withing 100 km).

I do not know of any reason why I would be disqualified from standing as a Candidate for this election.
