SUBJECT: Child and Family Update - Post-Community Comprehensive Plan (CCP) Ratification

**Purpose:** This document provides a status report and summary of actions taken by the Social Development Department regarding Child and Family matters since the ratification of Tl'azt'en Nation Comprehensive Community Plan (CCP).

# **Summary of Current Status**



Tl'azt'en Nation Members voted and ratified the Tl'azt'en Nation Comprehensive Community Plan (CCP) at the Annual General Meeting on **September 13, 2023**. The CCP speaks directly to Tl'azt'en Nation Members' desire for the future of child and family services. Since the ratification of the CCP, Tl'azt'en Nation Administration began on an implementation plan for the CCP, and **children and families** was identified as a **critical area** for focused planning and action.

In November 2024, Tl'azt'en Nation Council supported work to build out a Tl'azt'en Nation Children and Families Workplan, through further community engagement. A working draft of this plan was finalized in December 2024. Chief Ed John and the Social Development Staff traveled to Vancouver to advocate for funding and resources for the plan. Components of our own workplan align closely with the purpose and eligible activities for ISC Capacity Building Funding. Therefore, Tl'azt'en Nation is excited to move forward with this funding proposal in alignment with our Tl'azt'en Centred plan.





# What can we expect to see happening this year?

- Implementation of key Tl'azt'en children and families' priorities in our CCP through increased committee work and a new working group with Tl'azt'en Members;
- A new position at Tl'azt'en Nation to build capacity closest to home;
- Engagement sessions in Tache and beyond;
- Tl'azt'en led research on the approaches of other First Nation communities regarding children and families?
- Tl'azt'en child and family services program development; and
- More opportunities to get involved and have your voice heard on matters most important to you and your family.

#### What is in it for Tl'azt'en Members?

- Focused Action on Child and Family Prevention Services: Children and families were identified as a priority area in the CCP. A comprehensive Children and Families Workplan, based on input from community members, will help us address critical needs and improve services in this area.
- Community-Driven Planning: The workplan is being shaped by continued engagement with Tl'azt'en members, ensuring it aligns with the community's values, traditions, and aspirations for our Tl'azt'en's children and families.
- Increased Resources and Capacity Building: The alignment of the workplan with Indigenous Services Canada (ISC) Capacity Building Funding means access to financial resources to support implementation. This funding will directly enhance the Tl'azt'en's ability to deliver effective, culturally grounded prevention programs for children and families.
- A Stronger Tl'azt'en: Create a stronger community and a brighter future for Tl'azt'en children and families, grounded in cultural strength, healthy community connection, and self-determination.
