## Councillor Mina Holmes Update ARPIL 2025

April was a busy and rewarding month as I continued to lead on files related to Economic Development and Major Projects, including the Pathways Forward Agreement (PFA), Tsel'kun, and PRGT, while also supporting the Finance team as needed.

One of the biggest accomplishments was the finalization of PFA3, which was signed by CSFN and the Province of BC by the March 31st deadline. While this work peaked in February and March, its impact carried into April, and I'm incredibly proud of the effort made by our collective. I worked closely with Chief Ed John, advisors Paul Blom and John Leidl, and our Natural Resources staff, particularly Scott Emmons, to bring this over the finish line. This agreement sets the groundwork for long-term Nation-to-Nation negotiations and helps move us toward an Agreement in Principle (AIP).

Work with the Province and Federal Governments – As part of our Economic Development Small Team, we've been actively engaging with Citizen Services – Connectivity Division to secure improved cellular coverage in our territory. We are pursuing the installation of a primary cell tower, with the potential for a second tower in Middle River. In January, a comprehensive proposal—developed by Paul Blom and Scott Emmons—was submitted to the Province of BC and Natural Resources Canada. In addition to connectivity infrastructure, the proposal includes funding support for on-the-land Keyoh Guardians, reinforcing our commitment to land stewardship and sovereignty.

Band Members Budget Presentation and 1st Quarter Band Members Meeting – A proud moment for me is our first presentation of the annual operating budget to the membership. When I joined the council, presenting the budget to the members was a high priority. In late fall, we discussed this at council and worked with the Executive Director and his managers to develop work plans and budgets on a timeline so we could present the annual budget we approved to the members in March. I look forward to improving this process throughout our term, using all the feedback we received to ensure we operate in a non-deficit manner.

#### New News Letter:

**Economic Development** Committee – Our small team continues to advance our economic interests. We are getting closer to presenting the best options for an economic development corporation structure, including drafts of articles, board structure, corporate protocol, business charter, business governance structure, key management processes, and an economic measure matrix for decisionmaking. This package will be submitted to the council and then to the membership for an update and subsequent decision. We anticipate that a corporation will be operational by the end of summer. A crucial aspect of this work is ensuring we establish a sustainable structure in which our community members see themselves participating and are informed about activities. For example, the currently proposed board structure includes an elder selected from the Elders Society or Group, a youth chosen from the Youth Council, two members at large elected by vote, and two professional businesspeople appointed by the council. We will be presenting an update and proposed structure(s) via zoom in the months of May and June leading up to the AGA.

Minister Brar Dinner/Meeting – On March 24th, Minister Brar, the Minister of Mining and Critical Minerals, along with TJ Parhar and Simon Coley from the newly formed Critical Minerals Office, visited Tachie. A significant amount of preparation went into planning this visit, from the initial invitation and coordinating with his staff to setting dates and timelines, as well as creating the actual activities. Minister Bran expressed his gratitude to Tl'azt'en Nation for their hospitality and the tour of our beautiful country. Building relationships with governments, neighbours, and other First Nations is vital for nation building and good governance. We are fortunate to have Chief Ed as our leader; he is exceptionally connected to various levels of government in BC and Canada. With just a phone call, he can secure funding or arrange a meeting with nearly anyone!



We were proud to host Minister Brar in our territory, where he had the opportunity to meet with community members and hear directly from them about their thoughts, concerns, and hopes for the future.

Council is also very thankful to Ruby Prince and Guy Prince for reaching out and helping make it possible to support some of our members in the Vancouver area in a drum-making program. This is a small but meaningful step in connecting with our members who live away from home, and we look forward to continuing this work.
